## Course fees and government contribution for pre-accredited training courses:

Inclusion Training do not charge a course fee for pre-accredited courses however if support is required in the classroom, an approved NDIS plan will be required.

## Fees for National Disability Insurance Scheme Participants

In addition to Inclusion Training's qualified trainers and assessors, additional supports in the classrooms are provided by Inclusion Training's team of dedicated tutors and Direct Support Professionals.

Inclusion Melbourne may provide direct support for personal care, meal assistance, self-care and social inclusion at Inclusion Training campuses as per individual requirements.

Inclusion Melbourne (Inclusion Training) are registered to provide Capacity Building and Core funded services under the National Disability Insurance Scheme. Charges are dependent on the support needs of the learner.

If a student wishes to enroll in one of our courses, we recommend you contact us prior to your NDIS planning meeting for us to develop an individualised financial plan of the costs involved to support you in the classroom.

If prospective student's already have an NDIS approved plan, please discuss this with us in order for us to tailor our services to support your goals.
